NOTICE IS HEREBY GIVEN that a public hearing will be conducted by the Town of Sheboygan Falls Town Board on Monday, December 1, 2025, at 7:00 PM at the Town of Sheboygan Falls Town Hall located at W3860 CTH O, Sheboygan Falls. The purpose of the public hearing is to consider a Land Division & Rezone Request from Ricky & Nancy Decker to divide parcel 59026385090, currently zoned A-2 (Agricultural Land District), into a 17.77 acre parcel (Lot 2) and a 2.23 acre parcel (Lot 1) and rezone Lot 1 to R-1 (Single Family Residence District). The request also includes splitting 3.04 acres from parcel 59026385080, currently zoned A-1 (Exclusive Agricultural Use District) and merging with Lot 2 and rezoning to A-2 (Agricultural Land District), the remaining 16.96 acre zoning classification to be determined; to sell the woods.
